"Code of Conduct" & "Mission Statement" of J.O.Y. Basketball. Please Read Carefully and Sign:

"If anyone competes as an athlete, he does not win the prize unless he competes according to the rules... Remember therefore Jesus Christ, risen from the dead..." (2 Timothy 2: 5-8)

These words of St. Paul, an athlete for Christ, serve as the "Code" and "Mission" of not only our Diocese Jr. Olympics but also our own Parish athletic programs. All participants, coaches, advisors, organizers, parish leaders, parents, and spectators are expected to keep high the ideals of these programs, which namely are:

- to **obey** the "**rules of play**";
- to **respect** the event supervisors and officials;
- to **promote** Christian athletic fellowship;
- to **maintain** a demeanor that is typical of a faithful, believing, God-loving Orthodox Christian;
- to **respect** all people involved in the program and to treat those people as one would the Lord Jesus Christ Himself

1. Parents **cannot** just drop off their children. At least one (1) parent or guardian **must** remain with their child(ren) during the time they are at J.O.Y. Basketball.
2. **No children are allowed to leave the building.** If children are caught outside **disciplinary measures** will be taken!!
3. Parents must **monitor** their children for safety.
